#### ORDER

The complainant alleged a justice of the peace improperly denied her requests for change of judge and a cost bond waiver. The commission reviewed the matter and found no evidence of ethical misconduct on the part of the judge. The statute under which the complainant sought a change of judge applies to superior court cases, not justice court cases. The order denying the request is consistent with the law and does not reflect bias. The fact that the judge ruled promptly on the cost bond waiver request is not evidence of bias. Without more, there is insufficient evidence to justify further investigation. The complaint is dismissed pursuant to Rules 16(a) and 23.
