On 1-08-2010 minute order filed 1-12-2010 docket code 027 The state is again given more time for disclosure see pg. 2. On pg. 6 a Rule 11 motion was made against my wishes by my deputy public defender. A bench conference was held and an order to deny the motion was made.

On 1-13-2010 minute order filed 1-19-2010 Docket code 120 with out my presence or knowledge a Rule 11 order granting Full Rule 11 Evaluation.

Judge Heu I didn't want to file a rule 11 and agreed on 1-8-2010 with me. Yet 5 days later she orders a full evaluation based upon my motion despite my earlier objection and without my presence or knowledge of these proceedings

On 02-02-2010 again without my presence or knowledge before Steven Holding a rule 11 notice of appointment is made Docket date 2-2-2010 - code 122. The hearing for competency on March 25-2010 I had a motion to dismiss the public defender in which a copy was given to the clerk before the judge came to the bench with copies going to the DA and Christian Whitney also. See minute order for 3/25/2010 Docket code 176 Filed on 4-5-2010 when I stated I filed to dismiss counsel and was not aware of the proceedings in Secret Court being held without my knowledge or presence He ordered the bailiffs to arrest me and place me in custody without bond. I was out of custody on a \$900. dollar secured appearance bond and have not missed any scheduled court dates. My next date is 4-29-2010. A motion to continue was also made without my knowledge or by whom. How can I be arrested when not present at secret court?
