The complainant alleged that one justice of the peace violated her rights by improperly recording the deed to her property 32 years ago and another justice of the peace burglarized her home 28 years ago before becoming a judge and again after becoming a judge. The commission reviewed the allegations and found no evidence to support the claims against either judge. The complaint is dismissed pursuant to Rules 16(a) and 23.

One day later, LaShan, Obadiah Jackson's son burglarized the Town & Country Animal Clinic at 1016 E. Southern Phoenix, Ar and stole my documents all on security camera & gave documents to Obadiah Jackson. Later Code Williams new judge, burglarized my home at Phoenix to steal documents. Now my deed is missing, and Obadiah Jackson aka Sita Barge is on my deed. I did not ever sell this parcel to Barge or anyone. Harlach never remembered selling the lot to parcel A to Jackson either. Jackson was also responsible for the death of my grandmother, Agnes V. Takafos. She was also fired for abusing nursing home patients at a nursing home at 23rd St & Southern.
