**COMPLAINT AGAINST JUSTICE OF THE PEACE OF THE ROUND VALLEY  
 JUSTICE COURT; JUDGE**

Sirs:

This is a formal complaint against Judge \_\_\_\_\_ in violation of Oath, Canon and the Code of Judicial Conduct, facilitating criminal acts including federal firearm violations under US Code Title 18 Section 922 and other felonies against Derringer including "obstruction of justice" of attempting to stop and block an appeal of CV-07-\_\_\_\_\_ Order of May 26, 2010 with Order of July 13, 2010.

On or about July 13, 2010 Judge \_\_\_\_\_ took over the case CV-07-\_\_\_\_\_ after reading the Motion for Reconsideration of the un-Constitutional Order by Judge David Antonini of May 26, 2010 in which \_\_\_\_\_ Constitutional and statutory rights have been continuously violated by Judge Antonini that continually defies and violates the Arizona state statutes **ARS 33-1704(C), ARS 33-1123, ARS 33-1126, ARS 33-1130, ARS 33-1133** in a deprivation of due process and equal protection against the Plaintiff.
