case's to be dismissed." All I ask for with Mr. is that I
would be allowed to take a blood test, to see if I am a match
to my dad. So I could give my dad one of my kidney's. That's all.
my defense Attorney and one of the police officers thought I was
crazy, because I'm not asking for my Freedom or for my case's
to be dismissed and that my request was very reasonable. Everyone
agreed and Mr. put an agreement in writing. I provided
the exculpatory evidence that the prosecutor and law enforcement
needed, to make the proper arrest. At the time, they only
had hearsay evidence and not any direct evidence for a probable
cause of arrest. I provided the direct evidence against the 2
young men who committed the murder and the arrest were
made. Several months went by and my Attorney, ERIC ENGAN
inquired why Mr. is not honoring the written
agreement! In April or May of 2009, Mr. Engan told me.
that I will not testify or say anything in court because Mr.
reneged on the written agreement. Mr. then stated
to Mr. Engan "Fuck, Mr. I don't need his testimony
in court, I have him on recording and I will use his tape recording
testimony in court without him!" And, then stated, "What will
everyone in jail think of him as a rat!" Mr. Engan was very angry
and related the conversation to me. Mr. put my life
