My Land lord, Lynne C. Sams requested to have the surveillance camera taken Cour but it was denied by Judge Carson. She too has been a victim of being audio/ vila taped by Paris and Williams. The surveillance camera is still on Paris' shop roof covering the entire front yard of my residence. Something is terribly wrong when a Judge allows this Sort of behavior. Managedon Please / YOTE: Because of the on-going havassment from Jon: Alice I no longer go outside to work in my yard. I feel like a prisoner in my home afrarel to talk in case its recorded & I'm
