**ORDER**

The complainant alleged that a superior court judge improperly reconsidered his prior ruling to stay the issuance of a writ of restitution while her case was on appeal. The commission reviewed the allegation and found no evidence of misconduct on the part of the judge. The judge reconsidered his ruling in accordance with A.R.S. § 12-1182. The commission is not a court and cannot change judicial decisions. Accordingly, the complaint is dismissed pursuant to Rules 16(a) and 23.
