ORDER

The complainant alleged that a superior court judge made improper rulings and had a conflict of interest. After carefully considering the complaint, the commission found no evidence of ethical misconduct on the part of the judge. The issues raised involve legal matters outside the jurisdiction of the commission. The fact that the complainant filed prior complaints raising the same allegations against other judges in the same court does not create a conflict of interest. Accordingly, the complaint is dismissed pursuant to Rules 16(a) and 23.
