ORDER

The complainant alleged that a superior court judge rushed to complete his forcible entry and detainer case by scheduling hearings too close together, did not allow him to subpoena a witness that could have made a difference in the outcome of his case, and denied his request for a new judge or jury trial. After reviewing all of the allegations and listening to the recordings of three separate appearances, the commission found no evidence of ethical misconduct on the part of the judge. The complainant requested a new judge or a jury trial after the judge first indicated his ruling, and then requested the opportunity to subpoena an expert. The requests were denied because they were untimely. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.
