## ORDER

The complainant alleged that a justice of the peace mishandled his motion to dismiss a civil traffic citation, improperly failed to appear at a hearing, denied his request to use his own equipment to record the hearing, and refused to issue a subpoena he requested. While procedural irregularities may have occurred in the court's processing of the complainant's case, the commission found no evidence that the judge engaged in ethical misconduct. Accordingly, complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.
