## ORDER

The complainant alleged that a superior court judge coached a witness and allowed improper testimony. After considering the allegations and reviewing the transcript, the commission found no evidence of ethical misconduct on the part of the judge. Based on the relevant portions of the transcript, the judge directed a police officer to refer to the holding cell located near the courthouse as a "room in the courthouse" to ensure the jury was unaware the complainant was in custody during the trial. Whether the judge allowed improper testimony is a legal issue outside the jurisdiction of the commission. The complaint is therefore dismissed in its entirety pursuant to Rules 16(a) and 23.
