The attached summary of civil rights criminally violated demonstrates how Arkansas Attorney Thomas Hyde, Attorney Thomas Mars, Attorney David Blackerby along with Julie Martin instead of entering into a contract with my Company as the Executive Committee directed, hired Lewis and Roca a law firm in Phoenix Arizona to attempt to stop me from signing a Contract with Wal-Mart Stores, Inc. – as you will see by any means necessary.
