ORDER

The complainant alleged that a municipal court judge was rude and mishandled his case. After considering the allegations and listening to the recordings of the hearings, the commission found no evidence of ethical misconduct on the part of either hearing officer. The recordings reveal that the judge did not treat the complainant poorly despite his conduct and quickly corrected what she determined was a problematic discretionary decision. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.
