ORDER

The complainant alleged that a municipal court judge did not give him enough time to hire a lawyer and made inappropriate statements. The commission reviewed the allegations and found no evidence of ethical misconduct on the part of the judge. The complainant did not submit a request for a continuance for more time to hire an attorney. The recording of the hearing revealed that the comments made by the judge were not inappropriate. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.
