ORDER

The complainant alleged that a municipal court judge violated his rights and improperly suspended his license after he attempted to appeal his traffic case. The commission reviewed the allegations along with the court file and found no evidence of ethical misconduct on the part of the judge. The problems involving the complainant's appeal were not caused by the judge, and whether the judge should have accepted the complainant's untimely brief as a request for reconsideration is a legal issue outside the jurisdiction of the commission. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.

This case started with a court trail on 02/25/07, an appeal was filed by me in proper time manner, around 05/14/07. At this time The Clerk of the court for Judge received a change of address from me, and told me usually I would have to fill out a form, but this time she would make note on record of my address change. Later checking mesa court records the change wasn't recorded till July of 07. But Mesa Court never submitted the appeal to Superior Court till 03/03/2008 (see attach mesa log dated 01/28/10 marked1a) falsifying documents (see 2a), stating they Mesa Court had submitted my Appeal ,and it was Superior Court fault for loosing the original filling. So the Clerk of Superior Court, not knowing the statues, or the fraud being portrait ed, sent a notice to the address proved by Mesa Court . The address given was a prior 12 month old address of mine, which was undeliverable, because the postal service only forwards mail for 3 mo.s. Now Superior Court marks the returned mail as an abandon Appeal, and notifies Mesa Court. On 05/28/08 Mesa Court sent a demand letter to my correct address for payment of the \$1800., which was received by me on 06/01/08. The letter gave me till 06/08/08 to pay the fines. I filed a response on 06/06/08 to Judge tell him of the address given to the Appeal Court was a prior12 month old address of mine, (see my response letter to Judge dated 06/08/08 marked 3a) that he was violation of my due process of law, and violating of my 14th amendment. Knowing how the Mesa court operates, I call almost every day to see what the Judge response would be till 07/03/08, and nothing was recorded, so I quit calling. Unbeknownst to me I find out what Judge did latter in the month of 07/08, he suspended my license, and on 03/1/09 (case #2009 while waiting for a traffic light to change, I arrested for driving on a suspended license, and again on 08/02/10 again setting at a traffic light, which case #2010 just had it trail on 04/08/11. At case 2010 pretrial I told the judge I wanted to hear in a common law court so I could straight out with a jury how all these tickets came about. Three days before the trail and till the night

before the trail 04/03/11, I received another call from Debbie , Judge LUE Sang Clerk of the Court saying, that the prosecutor wanting a postponement and all they wanted was my position on allowing a continuance or not . Debbie also told , weather or not I gave my position or not Judge Lue Sang would make a ruling tomorrow, on the schedule date for the trail . The next day I arrived just before the trail was suppose to have been at 4pm with my written reply ,but all were present for the trail , I told the judge before the trail that I never received discovery s item from the prosecutor ,and that I was not prepared which she made short of it ,. I demand to be heard only in a common law court , she told me flat out no , and again pushed to start the trail, I ask if I was entering into a contract by agreeing to start the trail ,and Judge Lue sang, said I was not.

I served our country and took the same oath Judge dishonors, and dishonors all Americans who serve this country, Mesa Court has no honor, and , and his conspirators strikes at the very heart of the 14th amendment, 42 U.S.C. 1983 speaks clearly of this kind of behavior. I want you to know the real damages this case or cases have caused, during a appeal in 04/07 I started a new job at 57 year old, with a National company for \$ 60 k plus, but because Adot record showed my license was suspended in 04/07.I was let go 4 days into the position. Eventually I lost a house I was buying, 2 +years of not being able to take my grand children out ,time and moments you can never replace. Jobs are hard to find let alone with out a divers license, and even harder at 63 yrs old. I may never own my own home because of loan requirements regarding age over 62. I lost my classic car, which was impounded, because of second suspension, and arrest return from the V.A. Hospital . The moneys I had were being used to make more money to get an attorney, and stay in case the cop on record lied, all over the wholesale auto business. Oh 2006 the place, and would be easy to prove,

I have tried to do what I as an American am suppose to do, stand up for our God given rights. I can only hope you do the same this country need that desperately. please call..
