ORDER

The complainant alleged that a superior court judge failed to recuse himself from her divorce case knowing he had a professional relationship with her ex-husband. She further alleged the judge altered the recording of the hearing to cover up her ex-husband's false testimony. After reviewing the allegations and the recording of the hearing provided by the complainant and from the court, the commission found no evidence of ethical misconduct on the part of the judge. That the ex-husband works for government does not create a conflict requiring the judge to disqualify himself. There was no evidence the judge altered the court recording of the hearing. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.
