ORDER

The complainants alleged that a pro tem superior court judge and superior court commissioner would not listen to the son's arguments or consider his evidence in his child support case because of racial bias.

The responsibility and mission of the Commission on Judicial Conduct is to impartially determine whether the judges engaged in conduct that violated the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After carefully reviewing all of the documents provided by the complainants and the court record, the members of the commission found no evidence of ethical misconduct and no violation of the Code on the part of either judicial officer. The allegations primarily concern court rulings, which are outside the jurisdiction of the commission. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.
