## ORDER

The complainant alleged that a pro tem justice of the peace made inappropriate comments and improperly provided legal advice.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission decided to dismiss this matter with a private warning urging the judge to be more clear in his communications with litigants, particularly where only one side is represented by counsel, and to review the law of concurrent jurisdiction between the justice court and superior court. The case is dismissed pursuant to Rules 16(b) and 23(a).
