ALSO MY LAPTOP HAD DIED & MY DEFENSE WAS ON THE LAPTOP. THE JUDGE REFUSED TO POSTPONE. I NEARLY DIED OF SEVERE HYPOGLYCEMIA. I REPEATEDLY ASKED FOR A POSTPONEMENT & WAS DENIED. JUDGE WAS CLEARLY BIASED AGAINST MY CASE & I COULD NOT PRESENT MY CASE AFTER NEARLY LOSING CONSCIOUSNESS. I REQUESTED A NEW JUDGE & CHANCE OR I WOULD & JUDGE IGNORED MY REQUEST. HE HAS REFUSED TO ORDER ROMEX TO REVIEW MY ENTIRE DEFENSE SPANNING 12 YEARS OF MEDICAL TESTIMONY. HE DOES NOT CARE ABOUT JUSTICE & THE FACT I AM FINANCIALLY & MEDICALLY INDIGENT. I CANNOT GET ANY ATTORNEY TO REPRESENT ME. THE ENTIRE JUSTICE SYSTEM HAS FAILED ME. I ASK FOR SEVERE DISCIPLINE OF THE JUDGE & AG FOR NEARLY KILLING ME BY VIRTUE OF UNTREATED HYPOGLYCEMIA & TOTAL INDIFFERENCE TO MY DIABETES.
