ORDER

The complainant alleged one superior court commissioner improperly thwarted his efforts to obtain orders in a child custody matter, and another superior court commissioner interfered with his presentation in support of his petition to obtain sole legal custody of his child.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the commissioners engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing all of the information provided by the complainant, the history of the case, and several minute entries, the commission found no evidence of ethical misconduct and concluded that the commissioners did not violate the Code in this case. The commission does not have jurisdiction to review the legal sufficiency of the commissioners' rulings. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.
