ORDER

The complainant alleged a municipal court judge and three superior court commissioners have discriminated against him and violated his legal rights.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge and commissioners engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing the information provided by the complainant along with the available minute entry orders in his case, the commission found no evidence of ethical misconduct and concluded that the judge and commissioners did not violate the Code in this case. The commission does not have jurisdiction to review the legal sufficiency of court rulings. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.
