ORDER

The complainant alleged a pro tem superior court judge improperly presided over both the complainant's criminal case and his marriage dissolution case and did not give him an opportunity to present his side in the dissolution proceedings.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing the information provided by the complainant and the judge's response, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. The commission does not have jurisdiction to review the legal sufficiency of court rulings. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

I have sent them a reply informing them that I believe that the judgement of Dissolution of Marriage in this case is illegal, UnConstitutional, Unlawful & wrongful, therefore I do not approve of the Form & Content that they sent me & will not do so until I am allowed Due Process of Law, & present the Evidence & facts pertaining to the criminal acts of And here Attorney her accomplices.
