## **ORDER**

The complainant alleged that a superior court judge denied her the opportunity to be heard and displayed an improper demeanor

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. The commission approved sending the judge a private advisory regarding the use of a gavel as opposed to a raised voice in getting litigants' attention and a judge's duty to cooperate with commission investigations. The complaint is dismissed pursuant to Rules 16(b) and 23(a).
