ORDER

The complainant alleged his speedy trial rights have been violated.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

On May 7th, 2013 (was presiding in
case for a motion filed by myself
for dismissal of then counsel
addressed my motion as a "Motion
to change of judge." To which I advised Commissioner
as incorrect and in fact a change of
or rather dismissal of court appointed counsel. The fact
that a consideration for change of judicial officer was
existing at the time is no coincidence. When learning
of the name of trial judicial officer in early 2013 there
were thoughts of seeking a change of judge although
awaiting new counsel was the, Telema, Commissioner
was a faculty teacher at my elementary
School Orangedale Elementary located on 51st Street and Oak
in Phoenix, Arizona. Also Commissioner was
a medical personell present after a failed death ptst
had on myself March 19th 2011 at Maricopa County Hospital.
Furthermore on 29th and morose at the then Raily's
fast food commissary. Myself was allowed to
place order before myself in a gesture as
Commissioner was dressed in medical
uniforms along with a group of technicians in late
2010 early 2011 on a subject. Also a brief appearance
in early 2011 was had for initial appearance in the
month of January resulting in release to pretrial services. These

facts listed are the supporting leverage used by Commissioner to behave unappropriately. The fact of seeing the said Commissioner in late 2010 or early 2011 at the fast food area and not recognizing this woman as a teacher at my elementary school was recognized by this Commissioner. There was direct verbal communication. The conversation consisted of "Thank you" and "Why would you do that?" My response was, "I always give service men and women cuts in line." Also I did mention that, "I can wait." There was a person with me also at this short interaction.

The uniforms were full body apparel with yellow and red colorings. A man along with the Commissioner expressed thanks and hastefully walked away, although the man was sincere. I then was arrested for a racial profiling that did directly lead to an illegal search and seizure in January of 2011. At this point of time while at initial appearance again the same woman from the then Rally's fast food was in the courtroom. Commissioner ordered to contact pretrial service to which this was done. Shortly lesser of unfamiliarity was starting to become aware. The unfamiliarity was a

a result of seeing this person (Commissioner) after over a decade and close to two decades. Not since the 1990's (early) had I seen and spoke to Commissioner and at that time as a teacher at a school I rode the school bus to and from. I am confident Commissioner

was aware on every instance whether recognition was apparent or not. Then in 2011 on March 19th I was transported to Maricopa County Hospital from United States Interstate 10 inside of Phoenix between forty and fortyeight Street exits after having my right hand middle finger cut by officers supporting a plan to end my life with appearance of myself causing the injury and responsibility on my behalf, another interaction was had between myself and Commissioner.

The failed death plot was not able to go as planned for two reasons. My senses were aware of an attempt on my life for a little over a week. Although a money contract plot wasn't learned until after the failed act. Having an idea led me to place myself in an area of people in a mass capacity. This helped me greatly since a person came to my aid and was witness to this act.
