ORDER

The complainant alleged a superior court judge treated him rudely and unfairly in a family court case.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing the complaint and the case history, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

In around april 2010, I filed for custody of my children. We, my Childrens Mother and I went to court in front of

I was asking for custody of my children and The mother, stated that she did not have a problem with my being granted custody.

States; "Well, I do have a problem with this! Why are you letting him have the children?" I was totally, shocked speechless.

then states something like hes always had the children and she admitted to being on drugs and then stated that C.P.S. had gotten involved (because was pregnant). And C.P.S. had told me to file for custody.

then states, oh if C.P.S. IS involved then we can't have these proceedings. (or something similar).

After winning a rule 59 against C.P.S. in Judge Court, in Sept. 22 and 23 '2011. It was ordered that the children be returned to me and that my lawyer help me establish custody. my lawyer had sent me some kind of parent visitation sharing contract. I assumed that she had filed this with the courts. had moved to and I and the kids went back to

pertaining to this case, she never answers me back. at least not so far in six months.

Yet, The respondents lawyer asked for certain records to be Supoenaed, and obtains them right away.

I have a right to be heard and to have a fair trial, by an Impartial Judge, and to be free from dishonest tactics from court officials, regardless to whether this is a good old Boy, Buddy System, out here or not. This happens to often here. We have very few decent Judges here in County.

a courtroom should represent truth not favoritism and should uphold the law, Its very design is to protect the innocent and seek the truth.

I know you cant change a ruling, but Im hoping that you can ask her to step off my case and Allow another Judge, like or someone with a neutral and impartial opinion to hear this case, Ive had to file Civil Complaints and charges against some of these people involved in my case, And feel like Im being retaliated against. there are many here with similar complaints.
