ORDER

The complainant alleged that a superior court judge was prejudiced and engaged in offensive behavior during court proceedings.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

I have proof as set by communication standards between myself and which is now being dismissed (text, email) proving he continues to lie and disrespect court and in kind the judge continues to disrespect me and allow things no judge that has any aspect of law would allow. My documentation provided to be evidence against him continues to be ignored by judge, Sheriff service ignored by judge, the only focus appearing to be had is to have snarky remarks regarding my cultural background and the clear dismissal of failure to follow court orders.

I am taking the first step in having this addressed by your office as I want to believe in the legal system. I will take this as far as I can through the law system and if necessary the media as this is not the way a court room is to be run.
