The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

Judge don't return the title to my. after very clear that the needye is frustrated with me. I am sorry that in my youth of may have been a difficult young man. However I am not that same young man I don't do drugo, I fallow instructions. after put me in wall for not paying a fine and don't give me credit for the time served then I'm imprisoned for a debt I can never pay and it becomes a remaliting show I realize that how the judge disposes of fines is his discression how over if the sole surpose of my confinement is that issue of sould recive credit for time sound alt is not the judge's got to teach me a lesson its its dispense Justice.
