ORDER

The complainant alleged a justice of the peace candidate improperly used a copyrighted photo on his campaign website, made false statements on his Facebook page, and did not reside in the precinct in which he was running for election. The candidate was elected and is now a justice of the peace.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found no evidence of ethical misconduct and concluded that the judge as a judicial candidate did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.
