ORDER

The complainant alleged that a justice of the peace bought drugs in exchange for sexual favors. The complainant also alleged a pro tem superior court judge denied him the right to be heard, to have a speedy trial, and was conspiring with the prosecution to keep him incarcerated.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judges engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found no evidence of ethical misconduct and concluded that the judges did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.
