ORDER

The complainant alleged a pro tem justice of the peace failed to grant his request for a mistrial in a criminal case.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The commission does not have jurisdiction to review the legal sufficiency of the judge's rulings. In addition, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

My third Court appointed attorney and I continue to wait for mv last attorney's, Mr. file. We wait for the Court transcripts of the trial and still no data and no justice. My attorney and I, months ago, as instructed by the court, requested my previous attorneys Mr. file and a copy of all Court transcripts relative to this case was requested as well. We have still received nothing, with no hope that this data will be presented in the near future. Since I have filed my Appeal, Notice of a Mistrial, and my allegations of Prosecutorial Misconduct, there continue to be several months of ZERO action.
