## **ORDER**

The complainant alleged a superior court judge was conspiring with his family to kill him. He claimed other judges were also involved in the conspiracy.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the superior court judge (or any other judge) engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found no evidence of ethical misconduct on the part of any judge and concluded that none of them violated the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.
