ORDER

The complainant alleged two municipal court judges, one now retired, violated her Sixth Amendment rights.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judges engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The commission does not have jurisdiction to review the legal sufficiency of the judges' rulings. In addition, the commission found no evidence of ethical misconduct and concluded that the judges did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety as to both judges, pursuant to Rules 16(a) and 23(a).

Commission member J. Tyrrell Taber did not participate in the consideration of this matter.

I wanted also to write about when I was ordered back to court for restitution fees for them coming in to my home to trap my cats that stated that they probably won't be any fees, she stated that in an earlier court appearance that she didn't think that there would be fees but on ~~and~~ she left before my case and ~~and~~ took her and DA who should be disturbed because if misconduct talk, the amount I need to pay the city back. After all the lies and deceit concerning my cats she had the nerve to ask what the fees will be. Then she said to me that I was taken to court on a video and I stated that I wasn't and that I was going to appeal and she stated yet I appeal. What was the sense, my cases went on for two years, I was my own attorney half of the time with no help.
