**ORDER**

The complainant alleged a justice of the peace engaged in inappropriate courtroom demeanor and retaliated against him for a prior report of alleged misconduct.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The commission does not have jurisdiction to review the legal sufficiency of the judge's rulings. In addition, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23(a).

Commission member Anna Mary Glaab did not participate in the consideration of this matter.

I acquired a degree in geology in which is unheard of from someone with my level of brain injury being in a comma for then losing my memory and identity for are the ones benefitting by these immoral incarcerations as they run many of the prisons and jails in this country, they run the facility. Head has promised to keep the jail facility in occupied. I had statistics in college and the only way you can guarantee those odds is by skewing the criteria, I would be in otherwise. I am suggesting serious corruption within the legal system all the way from the sheriff's to the district attorney to the judges. I will let you decide.

I have enclosed a DVD with the videos from my home security camera system that were reformatted into a MP4 format that can be easily played and areas of interest were zoomed in on for more detail. I had this done by a video production facility as the original videos are encrypted in which a set up wizard must be installed in order for it to be played on each individual computer, difficult for some to figure out. There are court cases in which I found myself in front of [redacted] via [redacted] where once again [redacted] denied me my right to due process of law by not accepting key evidence into the hearing. This slanted the cases against me which I feel is judicial misconduct. He is a judge not a god.

The first case involved my [redacted] and was held on [redacted]. My [redacted] harassed me while working on [redacted] then misconstrued [redacted] were to the two deputies she had called on me [redacted] confusing them on what to do. During the hearing I tried to introduce several key pieces of evince one being a [redacted] with the [redacted] that she had them confused where the property boundaries were. The second key piece of evidence I introduced was [redacted] property lines clearly showing the easement road next to my house and back to [redacted] was 100% on my property, no question. This made [redacted] a bald faced liar, and she [redacted] ignored this key evidence and found in her favor for the injunction against harassment. I tried to get one against her through the [redacted] but could not get the two sheriffs involved to amend their report to reflect the facts I had revealed to them that day [redacted] that she came and started yelling and harassing me when I was working on [redacted] on my own property, my hearing with [redacted] denied the injunction. She couldn't afford that with her [redacted].

The second case involved [redacted] who had abused a previous injunction she had issued [redacted], we had mutual injunctions against each other at that time as [redacted] had left threatening messages on my phone after they had acquired the temporary injunction several weeks earlier. I had a sheriff report where to sheriff's had listened to the threatening messages designating my protective order, she lied about circumstances to get hers and I didn't catch it for the hearing. [redacted] later on she misused the injunction by making false allegations against me, having me arrested and spending [redacted] in jail for something I did not do. She claimed I [redacted] near her house violating the court order. [redacted] wrote letters in my defense that they never heard me [redacted] the whole day as I was working in my yard. With these statements my attorney [redacted] was able to get the violation of the order dismissed.

Just before her protective order was to expire she requested another one not from the [redacted] where she had acquired the first, but from the [redacted] court with [redacted] under the name [redacted] this time. The hearing was held on [redacted] where I had previously introduced key evidence to the court in how [redacted] had misused the previous protective order by having me falsely arrested with misinformation. Exhibit #1 were the threatening messages [redacted] left on my voicemail and the second exhibit was the sheriff's report from those threats helping me to also get a protective order. Once again [redacted] was rude, condescending, and disallowing of my key evidence that was the foundation for my arguments. Please listen to the transcripts from these two cases and investigate this corrupt judge for judicial misconduct. Thank you, [redacted].
