ORDER

The commission initiated an investigation against a justice of the peace who allegedly used his judicial title in an improper manner to further his personal business.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found the judge's title and position were used to advertise a personal business. While this was improper under Rule 1.3, the Scope Section of the Code of Judicial Conduct provides that it is not intended that every transgression will result in the imposition of discipline. The commission decided, after considering all the facts and circumstances, to dismiss the complaint pursuant to Rules 16(b) and 23(a), but to issue a warning letter to the judge, directing him to ensure that his title and position are not used to advertise any personal business.


