**ORDER**

The complainant alleged a superior court judge improperly altered his sentencing transcript, improperly refused to order the Department of Corrections to provide him with nutritional supplements, and imposed too harsh of a sentence on him. Additionally, the complainant made allegations of improper conduct by individuals who are not within the jurisdiction of the commission.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The commission does not have jurisdiction to review the legal sufficiency of the judge's rulings. In addition, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23(a).

Commission member Peter J. Eckerstrom did not participate in the consideration of this matter.
