Disposition of Complaint 18-089

ORDER

The complainant alleged a superior court judge was biased against her and slandered her. Next, the complainant alleges a superior court commissioner did not afford her an opportunity to be heard, and allowed an inaccurate physical description to be used in an order of protection proceeding. Finally, the complainant alleges another superior court commissioner improperly denied her an order of protection.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judicial officers engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The commission does not have jurisdiction to review the legal sufficiency of the judicial officer's rulings. In addition, the commission found no evidence of ethical misconduct and concluded that the judicial officers did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23(a).

In I served an Order of Protection on my, then, husband. I'll refer to him as my ex and Order of Protection as O of P. Now in I learned he had an O of P on file out of vindication because I ruined his record by serving him one in He had threatened me about this. He is abusive sometimes, you wouldn't know it, and at times can get out of hand. He can be physically abusive when told of his insecurities or wrong-doings. He has a thing about choking me or holding me to get his way. Included, he help put me on Social Security Disability for the wrong reason and as a result was I was misdiagnosed and it was mishandled so I was mislabeled and SSA is having me appeal it

My ex and I had not been on good terms because I've been asking for a divorce and he kept getting worse with his verbal threats and mental/physical abuse. He went as far as to cut me off financially so I would rack up debt in our divorce. I had to pay for survival on credit. I wrote about this in our divorce – I did not know to write a motion, my ex did. So, we were arguing and he started threatening me again, so on I went to get an O of P on my ex with who denied it and gave us a court date to settle matters, he never did.

only talked with my ex he never talked to me. My ex used this outstanding O of P to get a Court Order put on me for a diagnosis I have been trying to change since the beginning of my misdiagnosis. My ex slandered me to by telling him I'm a "Violent Paranoid Schizophrenic", I am not violent unless I have to defend myself but I don't dare take on an ex that has been through I always let him choke and bend me over backwards or choke and yell at me, which is why I never had marks on me, because if I defend myself he will attack harder. Once he was flailing my wrists around and he used my hands to hit himself in the nose to make it bleed and I was arrested for this because he can manipulate the Police with his words and hide his actions.

Defense doesn't always help when you're being attacked. also never
look up my driver's license to match it up with the description on the O of P. The
Order has the wrong DOB, weight, height, and anniversary date. My ex knows my
weight, I tell him all the time and he knows my DOB, height, and our anniversary
date we were married almost (See Enclosed)

When the O of P was served the Police did not match up my driver's license to it
either and I was arrested twice. I'm the one whom called the Police both times.
After knee surgery my ex pushed me down onto the ceramic tile hard, my knee
gave out and I bruised my hand and other knee, with a small scratch. No one took
pictures because they were not noticeable and had already sided with my ex.

wrote that my ex has to provide "moderate accommodations" to
which he did not and I had to pay out of pocket for surviving after a holiday –
I was arrested on the I never received
reimbursement for this because whom divorced us, used this
slander too of "Violent Paranoid Schizophrenic" and still found me competent to
withstand a divorce yet, still claimed I was SMI (Seriously Mentally Ill).
notes Enclosed). My ex wrote and slandered me with
the same words, was biased the whole divorce.

Back to - My ex was gloating telling me about how Judge
and he were laughing at me because I, the "Violent Paranoid
Schizophrenic", was trying to serve somebody with an O of P (on my ex). Judge
is clearly in the wrong for becoming biased and taking this into
consideration for an O of P on me, the victim. did the same when it
came time for my O of P to serve my ex first. claimed it was too
involved and he knew before I came to him, maybe speculation, that I was being
slandered. told me before he talked to me he had a conversation
with . He also looked me up in the courts. I was charged with
domestic violence but it was in self-defense, like I truthfully stated above, and it
was dismissed by a of the courts there because I had to go to
diversion. (See Enclosed Dismissal Order). I do not know how to sue for
defamation by these three Judges. I don't think it's allowed. Because it is now on
my Court Order that I am violent and the one whom is hiding his violence and
getting away with it is my ex that concluded on my ex's side
along with that serve under Now I

have to, because of [REDACTED] decision, after our divorce I have to live with my ex-husband. This is very distressful to me. I'm in the middle of suing someone whom hit my vehicle and is trying to provide this evidence to sway a Judge handling this case outside of court, [REDACTED] – I'm cautioned too I don't want [REDACTED] to become biased too.
