Disposition of Complaint 18-317

ORDER

The complainant alleged a superior court judge did not afford her an opportunity to be heard, engaged in improper demeanor, and made improper rulings in a probate proceeding.

The responsibility of the Commission on Judicial Conduct is to impartially determine if a judicial officer engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The commission does not have jurisdiction to review the legal sufficiency of a judicial officer's rulings. In addition, the commission found no evidence of ethical misconduct and concluded that the judicial officer did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23(a).

Commission member Christopher P. Staring did not participate in the consideration of this matter.

In a hearing on Judge violated the Arizona Code of Judicial Conduct, Rule 2.2. Impartiality and Fairness by not allowing me to present my case or the evidence I gathered. She only spoke with attorney and I could not hear everything they were discussing. Judge then asked me if I would like to be heard at a phone hearing I said yes but I did not know Status Conference was the legal name for the hearing. Since I was not familiar with all the legal names Judge violated the Arizona Code of Judicial Conduct, Rule 2.3. Bias, Prejudice and Harassment by proceeding to shout out loud, in a condescending voice, that I don't even know the legal names used in these hearings and that she and have been in many court cases together and they were much smarter than I was. Then Judge suggested that I meet with PLAP before coming into court. I did not say anything after that so I did not get the chance to tell her I had already met with PLAP and they instructed me to become Personal Representative of my Father's estate. She showed no patients or courtesy towards me whatsoever. I cannot believe that a Judge would be so cruel to someone whose Father just passed and they are only trying to obtain a memento for themselves and their sisters. I am sure that all that was said is recorded in the court transcripts.
