

ORDER PROMULGATING RULE 40, ARIZONA RULES OF CRIMINAL PROCEDURE, AND AMENDING THE FORMS APPENDED TO THE ARIZONA RULES OF CRIMINAL PROCEDURE AND CERTAIN OF THE COMMENTS TO THE ARIZONA RULES OF CRIMINAL PROCEDURE

TT IS ORDERED promulgating Rule 40, Arizona Rules of Criminal Procedure, as shown in Attachment 1 hereto, effective January 1, 2008.

IT IS FURTHER ORDERED abrogating in their entirety the Forms attached to the Arizona Rules of Criminal Procedure and substituting in their place revised Forms with the exception of Forms 4(a) and 4(b) [See R-07-0003], as shown in Attachment 2 hereto, effective January 1, 2008.

IT IS FURTHER ORDERED making the following technical, conforming revisions to the commentary set forth in the Arizona Rules of Criminal Procedure, as follows:

- 1. The first paragraph of the Comment following Rule 2.3 is hereby deleted.
- 2. The reference in the Comment following Rule 3.2 to "Forms II(a), II(b) and III" is changed to read "Forms 2(a) through 3(b)."

RULE 40, ARIZONA RULES OF CRIMINAL PROCEDURE

Rule 40. Forms

The forms contained in the following Appendix are recommended for use in Arizona courts and are sufficient to meet the requirements of these rules. All forms shall comply with the formatting requirements of Rule 10 Rules of Civil Procedure.
