

## Rule 31. Regulation of the Practice of Law

# Rule 41. Duties and Obligations of Members

The duties and obligations of members shall be:

- (g) To abstain from all offensive personality avoid engaging in unprofessional conduct and to advance no fact prejudicial to the honor or reputation of a party or a witness unless required by the justice of the cause with which he-the member is charged.

# Comment [2007 Amendment]

Lawyers, whether or not engaged in the practice of law, should act honorably and treat others with courtesy and respect. Unprofessional conduct, as defined by Rule 31(a)(2)(E), during the practice of law may result in discipline pursuant to Rules 41(g) and 53(j). Specified conduct outside the practice of law, such as conviction of a felony, Rule 53(h), or engaging in conduct involving dishonesty,

fraud, deceit, or misrepresentation, Rule 42, ER 8.4(c), and Rule 53(a), may also be grounds for discipline.
