FURTHER ORDERED that failure to comply with this order may subject Respondent to penalties to be imposed by the Court up to and including incarceration.

FURTHER ORDERED that Respondent shall pay the costs incurred by the State Bar, plus reasonable attorneys' fees, the amount to be approved by this Court on application by the State Bar.

FURTHER ORDERED that Respondent's Request for Sanctions is denied.

FURTHER ORDERED that the State Bar's Motion to Strike is denied.
