This matter having come on for hearing before the Disciplinary Commission of the Supreme Court of Arizona, it having duly rendered its decision and no discretionary or *sua sponte* review occurring,

IT IS ORDERED, ADJUDGED AND DECREED that **KENNETH J. WHITEHEAD**, a suspended member of the State Bar of Arizona, is hereby suspended from the practice of law for a period of four (4) years with terms and conditions, effective the date of this judgment and order, for conduct in violation of his duties and obligations as a lawyer, as disclosed in the Disciplinary Commission Report. The terms and conditions of suspension are as follows:

Respondent shall contact LOMAP within ten days of the final judgment and order and enter into a LOMAP contract for the limited purpose of monitoring retention and return of client files.

IT IS FURTHER ORDERED that **KENNETH J. WHITEHEAD** shall be placed on probation for a period of two (2) years, effective upon reinstatement. The terms of probation are to be determined at the time of reinstatement.
