The Court granted sua sponte review of this matter to modify a portion of the sanction. The parties agreed to a period of suspension requiring formal reinstatement proceedings. The parties also agreed that respondent would be placed on probation with the Member Assistance Program (MAP) during the term of her suspension. Rather than imposing probation during her period of suspension, respondent's continued participation in MAP should be imposed as a condition of reinstatement. Accordingly,

IT IS ORDERED, ADJUDGED AND DECREED that **KATHY M. O'QUINN**, a member of the State Bar of Arizona, is hereby suspended from the practice of law for a period of six months and one day, effective thirty (30) days from the date of this order, for conduct in violation of her duties and obligations as a lawyer, as disclosed in the Disciplinary Commission Report.

IT IS FURTHER ORDERED that as a condition of reinstatement, **KATHY M. O'QUINN** shall continue participation in MAP and remain in compliance with the terms of the December 19, 2005 contract. The terms and length of probation will be determined at the time of reinstatement.

IT IS FURTHER ORDERED that **KATHY M. O'QUINN** shall pay restitution in the following amounts to the following individuals:

John and Joyce Edmonds: \$600.00

IT IS FURTHER ORDERED that Respondent shall comply with all the provisions of Rule 72, Rules of the Supreme Court of Arizona, including, but not limited to, Rule 72(a), which requires that Respondent notify all of her clients, within ten (10) days from the date hereof, of her inability to represent them and that she should promptly inform this Court of her compliance with this Order as provided in Rule 72(e).

IT IS FURTHER ORDERED that Respondent shall comply with all rule provisions regarding reinstatement proceedings.
