Rappeport shall notify all his clients within ten (10) days from the date hereof of his inability to continue to represent them and that they should promptly retain new counsel, and shall promptly inform this Court of his compliance with this Order as provided by Rule 72(e), Rules of the Supreme Court of Arizona.
