

Administrative Order No. 2003-<u>35</u>

Administrative Order No. 91-30 established the Advisory Committee on Alternative Dispute Resolution to assist the Arizona Judicial Council in carrying out its responsibilities. The Committee has performed its charge of assisting the Council in the development of policies designed to improve efficiency in court operations.

While the Advisory Committee on Alternative Dispute Resolution has identified issues that require attention, Arizona's current budget crisis has dictated the need to reduce the number of Supreme Court committees. Accordingly, it is advisable to continue the Advisory Committee on Alternative Dispute Resolution for a limited period of time.

Now, therefore, pursuant to Article VI, Section 3, of the Arizona Constitution,

IT IS ORDERED that the Advisory Committee on Alternative Dispute Resolution is continued until December 31, 2003, as follows:

1. PURPOSE:

The Committee shall address priority objectives and tasks which it determines can be completed before December 31, 2003.

2. MEMBERSHIP:

The membership of the Committee existing as of December 31, 2002, is attached as an appendix. The listed members are continued as members of the Advisory Committee on Alternative Dispute Resolution until December 31, 2003.

3. MEETINGS:

Meetings shall be scheduled at the discretion of the Committee Chair. All meetings shall comply with the Open Meeting Law policy of the Arizona Judicial Branch.

4. **REPORTS**:

The Committee shall submit, at a minimum, a final report of its evaluation or recommendations to the Arizona Judicial Council in December 2003.

5. STAFF:

The Superior Court in Maricopa County Alternative Dispute Resolution Department has offered and shall provide staff and facilities for the Committee and, as feasible, may conduct or coordinate research as requested by the Committee.

IT IS FURTHER ORDERED that the Honorable Raymond W. Weaver, Jr. shall chair the Advisory Committee on Alternative Dispute Resolution until December 31, 2003.

IT IS FURTHER ORDERED that the Advisory Committee on Alternative Dispute Resolution is discontinued effective December 31, 2003.
