



SUPREME COURT OF ARIZONA

ORDER APPOINTING CHAIRMAN AND MEMBERS OF THE
ADVISORY COMMITTEE ON CHILD SUPPORT

Administrative Order No. 90-12

In accordance with Administrative Order No. 87-17, the Chief Justice may appoint advisory committees of the Council on Judicial Administration. The Advisory Committee on Child Support having been created by Administrative Order No. 87-26, now, therefore,
