The undersigned law enforcement officer had reasonable grounds to believe that the plaintiff is in immediate and present danger of domestic violence based on an allegation of a recent incident of actual domestic violence. Those grounds were made known to the issuing judicial officer. The judicial officer has authorized the issuance of this Emergency Order of Protection. Pursuant to said authorization, IT IS HEREBY ORDERED:

That the defendant shall not threaten, intimidate, endanger, assault, commit an act of custodial interference, unlawfully imprison, kidnap, trespass, or damage the property of or commit any other disorderly conduct against the plaintiff or any minor child of the parties; that the defendant is excluded from the residence where the plaintiff resides; that the defendant shall not go on or near the place where the plaintiff resides or is employed; and that the defendant shall have no contact with the plaintiff in person or by telephone.
