This order is required to appoint or confirm the designation of new members of the Arizona State, Tribal and Federal Court Forum to replace members who have resigned or been newly designated. The Court is advised that Judge William F. Garbarino, Arizona Court of Appeals; Chief Judge Thomas F. Bartlett, Colorado River Indian Tribal Court; and Judge Delford Leslie, Hopi Tribal Court have resigned and that U.S. Attorney Janet Napolitano has changed her designee.

Administrative Order 94-65 authorizes the Chief Justice to appoint state and tribal judicial members and authorizes the U.S. Attorney to send her designee.

IT IS ORDERED that Judge Phillip Toci, Arizona Court of Appeals, Division 1 and Judge Gloria Kindig, Chief Judge, Hopi Tribal Court are appointed to fill the vacancies left by the resignations of Judges Garbarino and Leslie and that Joe Lodge shall serve as the U.S. Attorney's designee.

IT IS FURTHER ORDERED that the membership list attached as Appendix A of Administrative Order 94-65 is amended to reflect these membership changes and is attached as Appendix A of this order.
