Discussion: Complaint Number NC09-C002:

On April 20, 2009, the Certification and Licensing Division ("Division") received a complaint involving a non-certificate holder over which the Board and the Division does not have jurisdiction. On May 8, 2009, Division Director Swetnam recommended the Board dismiss the complaint with prejudice for lack of jurisdiction and recommended the matter be referred to the entity which holds jurisdiction. Pursuant to ACJA § 7-201, a copy of the recommendation to dismiss was forwarded to the complainant. On May 27, 2009, the Division received a request for Board review of the recommended dismissal from the complainant. On June 17, 2009, the Division received supplemental materials from the complainant. It was recommended the Board dismiss the complaint with prejudice and refer the matter to the entity that holds jurisdiction.

Complaint Number NC09-C003:

On April 20, 2009, the Division received a complaint involving a non-certificate holder over which the Board and the Division does not have jurisdiction. On May 8, 2009, Division Director Swetnam

recommended the Board dismiss the complaint with prejudice for lack of jurisdiction and recommended the matter be referred to the entity which holds jurisdiction. Pursuant to ACJA § 7-201, a copy of the recommendation to dismiss was forwarded to the complainant. No request for Board review has been received from the complainant. It was recommended the Board dismiss the complaint with prejudice and refer the matter to the entity that holds jurisdiction.

Report recommends the denial be upheld.

recommendation to petition the Superior Court for issuance of a Cease and Desist Order enjoining Ms. Baquet from engaging in any activities which require certification and from representing herself as an Arizona certified reporter until such time as she is granted certification by the Board. At the May meeting, the Board moved to defer taking action on the non-certificate holder pending resolution of the certification application denial hearing. Hearing Officer Marshall's report has been reviewed by the Board and the denial of her application was affirmed. Discussion of a Consent

Agreement and a possible Cease and Desist Order.

inquire as to whether Ms. Baquet is willing to stipulate to a Cease and Desist Order, establishing a deadline for Ms. Baquet's response in 21 days; if Ms. Baquet does agree, the Board will proceed with
