a) Revoke Casto-Moroz's certification, certificate number 50254, pursuant to ACJA § 7-201(H)(24)(a)(6)(i);

b) Issue a cease and desist order enjoining Casto-Moroz from engaging in any activities which require certification or representing herself to the public as a certified reporter for the period of any revocation and until such time as any and all conditions for reinstatement are met in full, as determined by the Board, pursuant to ACJA § 7-201(H)(24)(a)(6)(g);

c) Order and mandate as a condition for reinstatement, Casto-Moroz participate in no less than ten (10) hours of continuing education in the curriculum areas of professional responsibility, ethics, and the rules of court, in addition to any hours otherwise required for renewal, pursuant to ACJA § 7-201(H)(24)(a)(6)(f);

d) Assess costs associated with the investigation and related disciplinary proceedings to be remitted no later than 60 days following entry of the Board's Final Order, pursuant to ACJA § 7-201(H)(24)(a)(6)(j); and,

e) Impose civil penalties in the amount of \$250.00 per found violation to be remitted no later than 60 days following entry of the Board's Final Order, pursuant to ACJA § 7-201(H)(24)(a)(6)(k).

Do not revoke but suspend Ms. Casto-Moroz's certificate for three (3) months subject to the remaining staff-recommended sanction conditions, letters b through e:

e) Impose civil penalties in the amount of \$250.00 per found violation to be remitted no later than 60 days following entry of
