Please refer to the information below to properly file your court documents.


You have TWO options to file your court documents generated on AZTurboCourt in the Maricopa County Justice Courts:

✓ Mail the filing to the court OR

✓ File at the court in person



Carefully read the instructions on the next page. The procedures for filing by mail or at the court (in person) are different. You must follow the instructions to properly file your court document/s.



MAIL THE FILING TO THE COURT

- 1) Print out a copy of your form/s in AZTurboCourt.
- 2) Make the correct number of copies of the form/s.
- 3) Mail the form/s, copies, filing fee, and self-addressed stamped envelope to the court and address at the top of the form/s (upon receipt the Court will mail additional information).

- Completed Form/s
- Correct Number of Copies
- Filing Fee
- Self-Addressed Stamped Envelope

FILE AT THE COURT IN PERSON

- 1) Print out a copy of your form/s in AZTurboCourt.
- 2) Make the correct number of copies of the form/s
- 3) Bring the completed form/s , copies, and payment for the filing fee to the court to file.





***Note:** Transfer forms are not available on **AZTurboCourt**. However, please be advised that filing a small claims counterclaim that exceeds \$2,500.00 requires the case be transferred to the civil division of the Justice Court. A counterclaim exceeding \$10,000.00 requires a case to be transferred to the Superior Court. A separate filing fee will apply in both instances and both transfer forms are available at the court.
